February 5, 2003

President Steele asked for a moment of silence for recent SKs: our member James Miller N8MAA, and members of the space shuttle Columbia, Kalpana Chawla KD5ESI, David Brown KC5ZTC, Laurel Clark KC5ZSU, Commander Rick Husband, Pilot Willie McCool, Michael Anderson, and Ilan Ramon. Then the pledge of allegiance was given, and introductions were made.

The minutes of the last meeting were published in the newsletter. The report was approved as published.

Mary Ann KB8IVS reported the treasury balances. The report was approved upon motion by George K3GP, seconded by Jerry K8CAT.

Larry KE8VE would like to have assistance with the Zero Beat.


The next meeting of AARC on March 5th will feature Dennis Morarity K8AGB with a program regarding power line interference.
