September Minutes

ALLIANCE AMATEUR RADIO CLUB

September 3, 2003

The regular meeting of the Alliance Amateur Radio Club was held at the Alliance Community Hospital on September 3, 2003, at 7:30 P. M., with Robert Steele K8RLS, president, presiding. Secretary David Glass W8UKQ kept the minutes. There were 20 members and two guests present.

The Pledge of Allegiance was given, and introductions were made.

The minutes of the meetings for June, July, and August were printed in the newsletter. The totals of the treasury balances were reported for each month. All of the minutes were approved upon motion by Jim K8LTG, seconded by Joe KC8TAC. A radiogram concerning the Bicentennial Ohio QSO Party August 23 was read.

Mary Ann KB8IVS reported the treasury balances. The report was approved upon motion by David N8NLZ, seconded by Joe KC8TAC.

Guests, Howard Miller, call pending, and Larry Williams WOMHJ, were introduced and welcomed.

Old Business: It was noted that the Special Event went well. It is

a good location for operating, but there is no public exposure. Inquiry will be made to the Park Board about having the event there next year and the possibility of having Field Day there, also. The number of certificates for QSLs has not been determined.

A letter of appreciation from Randy Crawford regarding the assistance for the Triathlon was read.

QSLs were received for the Mile Branch Grange Fair operation. Joe KC8TAC sent some out.

Joe KC8TAC was commended for his life saving efforts at the Portage Hamfest.

The All Stark County two meter simplex contest is September 7.

There was discussion regarding the van. After the discussion, a motion was made by Don K8OMO, seconded by Dean KA8GRC, that we sell the van for \$___ or best offer, as is, where is. The motion was approved. Then, a motion was made by Jerry KG8RN, seconded by George K3GP, to put an advertisement with a picture in Auto Trader until sold. The motion was approved. It was suggested that the president has the power to make the final decision on this matter.

There was no information about a tour of Channel 45.

The possibility of securing a generator for the club was brought

up. It was suggested to sell the van first.

Doug Bowling's son has a program about APRS. It will be scheduled after the first of the year.

Elections will be at the October meeting.

The FISTS Club event is September 13. Call Don K8OMO to get permission to use W8LKY. He will need accurate logs of such operations.

Butler, Findlay, Medina Hamfests were announced. Bob Wright's family wants the antenna taken down soon. There was discussion about eliminating CW on tests. The New York Times printed an article about ham activity during the blackout. There are video tapes available about the Van Wert tornado last year. Jerry KG8RN received a thank you from Ed Hall for the associate membership.

The BPL, Broadband by Power Lines, was discussed. A motion was made by Jerry N8SH, seconded by George K3GP, to make a donation of \$___ to ARRL for the BPL special spectrum defense campaign. The motion was approved.

A motion was made by Don K8OMO, seconded by Jerry KG8RN, to use the picture of the bicentennial barn logo on the special event certificates. The motion was approved.

WD8IHP, Ohio Section Emergency Coordinator Becomes Silent Key

that was the law Larry wanted it."

A few days later Joe forwarded the following message which he had sent to the league:

I received the following message from Joe Phillips, K8QOE:

Larry Rain, WD8IHP, Ohio Section Emergency Coordinator for almost 4 years, became a silent key Tuesday, September 9th, after suffering a massive coronary at his home in Mansfield, Ohio. He was 64. He leaves his wife, Bonnie, N8XLU, and two children.

Before taking Ohio's top emergency coordination job, Larry served his local club, InterCity ARC in Mansfield for more than two decades in every office possible. He was county emergency coordinator, and served for nine years as DEC. During that time Larry also became the driving force in the formulation of the SKYWARN program throughout Northern Ohio.

Before retiring after almost three decades of service, Larry was a professional fire investigator for the City of Mansfield Fire Department and was part of hundreds of arson investigations for the Richland County Sheriff's Department.

"He was just the perfect SEC," said Ohio Section Manager, Joe Phillips, K8QOE, "Because his professional life prepared him well for understanding the dynamics of volunteer communications groups (ham radio) with civil emergency groups. He seasoned this knowledge with great humor and a common touch which earned the respect of all 88 Ohio county emergency groups he supervised and the governmental agencies, both state and local, he worked with."

Larry was appointed SEC on January 2, 2000, and immediately began to fill vacancies in the EC positions throughout Ohio - reducing the vacancies from 24 to eight in a matter of months. He also immediately began making Ohio's traffic nets a major part of the state's emergency response plan. Along with Ohio Single Side Band Net officials, Larry arranged procedures for DECs to call the OSSBN into emergency session when necessary - a major improvement in the Ohio Response Plan.

As the SEC in the state which hosts the Dayton Hamvention, Larry organized the Amateur Radio Emergency Service forum at Hamvention the past three years - always having personators from ARRL Headquarters at Newington. SECs throughout the country knew and respected Larry's work in Ohio.

He was always on the road throughout Ohio in performance of his duties. Just this past weekend, Larry participated in the Great Lakes Division Convention in Findlay.

"He handled leadership with great perspective - always taking his duties seriously but never himself seriously" said SM Phillips, "Everyone working with Larry was always at ease because

The great work of Larry Rain, WD8IHP (SK) must go forward. In that spirit I have asked John Chapman, WB8INY, of Columbus, District Emergency Coordinator for District Seven, to serve as Interim Section Emergency Coordinator from now until November 1, 2003. John has a close and excellent relationship with the Ohio Emergency Management Agency and the Ohio Red Cross. 
In case any of you don't already know, Jim Ferguson's mother passed away earlier this month. Jim has our deepest sympathy and condolences. □
