NO CODE

We have reports that the ARRL advisory board passed a resolution, 9 to 6 to recommend a no code test. This will be by VE testing only and is to include some of the technician elements. Privileges are to be on the 220 Mhz band and up. It will be called a Communicator Class license, so it appears the Novice does not have to worry, it does not appear that it is going to replace the code test for Novice, or the Novice class, we will see as all details become known. COMMENT!!! by KB8GCF

Well, some will be screaming about all the negative aspects of a no code test, some the positive aspects. Truth is, we all have a voice, if we did not use it, we must accept what happens quietly.

My personal feelings are mixed, I enjoy code, under the present system, it is the only thing that makes the Novice license and upgrades hard. With multiple choice answers to set questions, you only have to have a good memory for facts or be a good gambler to pass the written element with little or no knowledge of the principles involved. The odds for the gambler with no knowledge, are 4 to 1, on each question.

I am a little biased on multiple choice testing, I was raised in a society where you did not have a question pool and no multiple choices to help you, you either knew the answer or you didn't. Though I don't know how the present system is, from my education in England, the type of question I would expect, is; What are the Novice privileges and power limits on 220Mhz? That is it. You must give your answer in writing, no choices.

Though most of us study for our tests, the written element can be passed with little or no study. Code does make us work for it.

From the other angle, communication during an emergency under weak band conditions. While I agree that you can get through better with code, if the band is out, it does not matter if you use CW or Phone, you are limited to the propagation in effect. There is also the other aspect, we assume there will be an operator with key, paper and pencil, ready to copy and send at the other end. With a tornado screaming through and confusion all around, I find it hard to visualize a person sat with key, pencil and paper. Truth of the matter is, many hams put away their key once they upgrade, I know of some that would find it hard to copy 5wpm now.

I relate the Ham tests to driving tests, though we can all visualize a situation where the automobile may not be of any use in getting to a remote location, or operating without gas. We would consider it silly if the driving test required us to be able to ride a horse!!!

Without any wish to offend those good people that operate as much or more CW as they do phone, in these days of solid state radio's and advancement in technology, repeaters everywhere and voice communication better than it has ever been, I feel that CW is relegated to the position of the horse, it is good to own a horse and be able to ride it, but the car is in.

So how do we keep interest in code and keep quality amongst the ranks of Amateurs? The test could be made a lot harder, if we must have multiple choice, all answers should be close to the right one, both in wording and content. For those interested in code, an endorsement on the license for those who pass the code test, would allow those who operate CW access to bands where phone was not allowed.

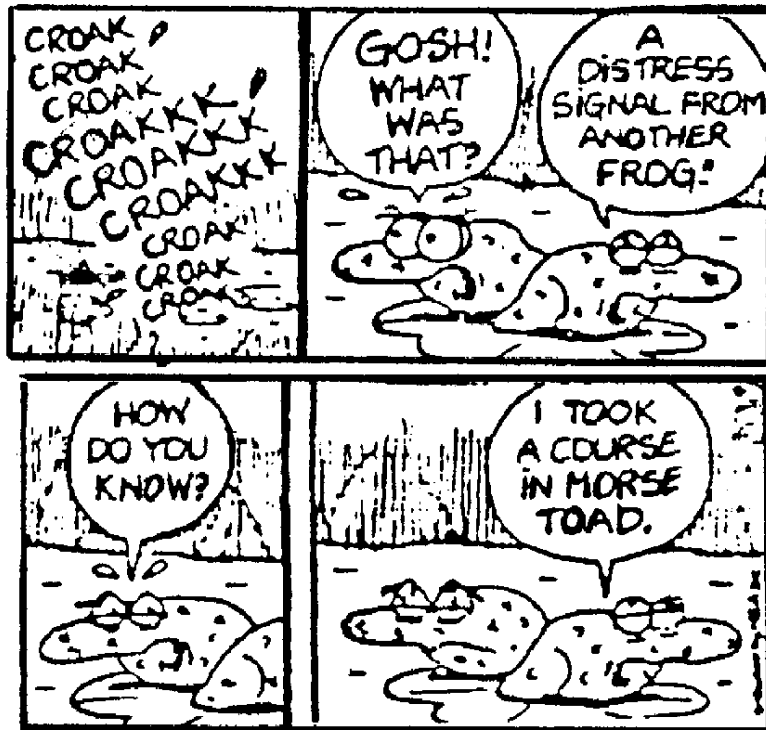
