This year, operating class 3A, we made 914 QSO's during Field Day weekend. They were split 533/381 between phone & CW, resulting in claimed score of 4,090 points, after bonuses. I've posted the last few years scores below, for comparison.

July Minutes

July 2, 2008

The regular meeting of the Alliance Amateur Radio Club was held at the Alliance Community Hospital on July 2, 2008 at 7:30 PM with club President Jim Ferguson, K8LTG presiding. The Pledge of Allegiance was recited, followed by introductions. There were 12 members present, along with Miriam Sanor and Tom Steele.

Club Secretary Don, AB8KV gave the Secretary's report, noting that the June minutes were in the newsletter. He mentioned that all the usual publicity for Field Day was generated and inquired as to whether any public officials attended. The response was that only a Sheriff's deputy had stopped by. With no other items to announce, the Secretary's report was approved on a motion by Joe, KC8TAC and seconded by Frank, WA8WHP.

Mary Ann, KB8IVS then gave the Treasurer's report. The report was accepted on a motion by John, KD8MQ and seconded by Joe, KC8TAC.

Old business:

--Vice-President John, KD8MQ gave a preliminary report on the results from Field Day. Among a number of items mentioned, there were 534 phone contacts and 380 CW contacts, with Alaska and Nevada the only states not worked. The 40 meter band was the most productive, followed by 20 then 80 meters. He noted that the networking software worked well and

facilitated moving from one station to another.

--President Jim inquired about which Subway had donated subs for Field Day. No one in attendance knew for sure but it was noted that Rick, KC8SUI would know as he had arranged the donation. A thank-you letter is to be sent to the donating Subway.

--Regarding previous discussions about prospective special events stations Jerry, KG8RN suggested skipping, at least for this year, the Mile Branch Grange fair due to the club's lack of any current set-up plans and the fair's proximity in time to Carnation Days. He proposed instead to have the club participate in the Knox Safety Day in September. President Jim agreed and there was a general consensus that the proposal made sense.

--The club is going ahead with the previously discussed plans to have a special events station on the last Saturday of Carnation Days (August 16). The plan is to set up around 9-10 AM and operate until 5 PM. The specific frequencies to be used were still to be determined at the time of the meeting.

--The subject of accepting donations during the Carnation Days special event station operation was brought up and discussed. Some club members were in favor of the idea with some opposed. After further discussion, the consensus appeared to be to accept donations. A motion to place a donation jar at the special event

station was made by Don, K8OMO and seconded by Larry, AA8NV with the motion approved by a voice vote.

--Don, K8OMO reported that the club was represented by himself and Rick, KC8SUI along with another ham at the Great Lakes Search & Rescue Expo at Berlin Center.

--VP John reported on the recent fox hunt practice run, noting that the fox had been found. The next fox hunt is scheduled for Sunday, July 20 starting at 2 PM at the Castle. The frequency will be 147.51. John also mentioned that he would like to try some fox hunting on the 440 band. Further discussion on that proposal is to follow.

New business:

--The Randolph hamfest is scheduled for July 27.

--Tom Steele mentioned that a friend of his wants to create a wireless internet hub to serve the immediate area around his home and wondered what the possible legal or licensing requirements might be. It was suggested that he consult the FCC website for information about such installations. A few members also noted that this had been done by others in the area with mixed success.

After the break, with no other new business to discuss, the meeting was adjourned at 8:35 PM on a motion by Joe, KC8TAC and seconded by Jerry, KG8RN.

Kansas Ham, Son, Electrocuted While Erecting Antennas

While putting up backyard antennas on the afternoon of Sunday, July 13, Edward Thomas, KC0TIG, of Kansas City, Kansas, and his son were electrocuted. The elder Thomas, 65, was pronounced dead at the scene. His son, 27, was rushed to the hospital but died later that day. Initial reports suggest that the antenna they were installing came in contact with 7620 V power lines. Neighbors reported a "loud popping sound" and the electricity went out on the block.

Jacob's 7 year old daughter witnessed the tragedy and ran to the neighbor's yard, calling for help. Byron Kirkwood and another neighbor attempted to perform CPR on the men; the neighbor also called 911.

Robert Mullendore, a spokesman for the Kansas City Board of Public Utilities (KCBPU), was quoted by Kansas City television station KSBH as saying it is rare to survive a shock as strong as the two men received: "There are people who will survive -- they're lucky by the grace of God, it's high energy, it's dangerous, that's why

it's up in the air -- you just have to be careful. Even those who survive have pretty wicked wounds and they are lifelong wounds." In the power business for more than 30 years, the spokesman said these accidents are "really rare," saying that he only sees something like this "every two or three years. If you're doing any kind of work like this, you just really, really need to be aware of your surroundings."

Chuck Kraly, K0XM, used to work for KCBPU; he built and maintained the substation that fed the circuit going to the Thomas home: "This is nothing to take chances with. In my almost 30 years as a ham -- and 27 years in the power utility field -- I have seen way too many 'accidents.' Stop and look. If it is close or seems that way -- *don't*. Find another place. High voltage lines are not forgiving. Your life depends on it. Please follow the warnings. *Anywhere* close is too close." -- *Thanks to Larry Staples, W0AIB, and others who contributed to this story (ed. Note: This was lifted from the ARRL home page.*

Power Supply Recall

(Jul 3, 2008) — On July 2, the US Consumer Product Safety Commission (CPSC), in cooperation with RadioShack, announced a voluntary recall of 13.8 V dc power supplies. The CPSC said that consumers should stop using these power supplies

immediately, as the "power supplies are wired incorrectly, posing electrocution and fire hazards." No injuries have been reported in conjunction with the power supplies that were sold in RadioShack stores nationwide from

October 2004-January 2008 for between \$50 and \$85. Manufactured in China, the CPSC said that the recall involves RadioShack 13.8 V DC Power Supplies, catalog numbers 22-507 and 22-508 with date codes

his XYL, won our Spring foxhunt. His Daughter rode along to keep them on course.

- Jim, N8PXW, from Uniontown, accompanied by Sebastian, who is a French exchange student. Jim was armed with a tape measure beam, and attenuator, but he also used a Roanoke Doppler unit which displayed the received signal direction on a circular readout of LEDs.

To the best of my knowledge, I have never seen a hunter drive straight to the fox. This time, it happened not once, but twice!

I left the starting line, intending to drive straight to the finish line to wait for the hunters to wander in. I picked up a soda on the way, and arrived at the

playground in time to see Tom, KC8QOD turning into the drive. A quick glance towards the back of the park, where the Fox Box was hidden, revealed that Jim, N8PXW had already arrived. It took hi all of 11 minutes to find the fox!

Tom came in a close second, with Dave, then Ron coming in. All hunters had found the fox in 30 minutes, or less.

The AARC fox hunt is one of a rotating schedule of Radio Direction Finding exercises. In the months where no hunt is scheduled, we just turn on the fox box for a couple hours, for practice. The hunt frequency is usually 147.51 MHz, although we are planning to do something on 440 MHz in September, and October.

Power supplies with a green dot on the product and the product's packaging have already been repaired and are not included in the recall. The CPSC recommends for consumers to unplug the recalled power supply immediately and take it to any Radio Shack store for a free repair. For hams throughout the State of Ohio this contest presents an opportunity to visit and enjoy the amenities offered by the seventy-three beautiful State Parks here in Ohio. You can spend the day or even spend the weekend at the park of your choice. No matter whether you are camping or staying at one of the outstanding lodges or resorts you will find that the parks are one of Ohio's greatest assets. This contest places a premium on working stations at the State Parks. That means that it is critical to have as many

August, 1988, (editor N8IAK)

- ⇒ The Zero Beat spotlight shone this month on Larry, KB8DWP (now KE8VE).
- ⇒ John, KD8MQ, and Pam, N8IAK both resigned their offices in the club, citing time pressures as the reason. Additionally, John resigned as ARES coordinator, and net manager, effective after the triathlon.
- ⇒ The next fox hunt was scheduled for Sunday, July 31. Ron, WC8F was to be the fox.
- ⇒ Dave, KC3CL was scheduled to spend two weeks in KG4 land. Ten, & Six Meter operations were planned.
- ⇒ Novice classes were coming up. John, Kd8MQ, and Jim, N8DZA (now K8LTG) were the scheduled instructors.
- ⇒ Field Day 1988 had been held at Hilliers Hill. We operated class 4A, and made 952 Q's (86% Phone / 14% CW).

August, 1993, (editor N8LVO)
