## ARRL Seeks Member Support for HR 2160

US House of Representatives bill HR 2160 is the first step toward the Board of Directors' goal of neutralizing anti-ham radio Codes, Covenants and Restrictions (CC&Rs) in private land usage contracts. The CC&Rs in question prevent amateurs from installing Amateur Radio antennas. The FCC has chosen not to extend its PRB-1 rule to cover CC&Rs. If passed, HR 2160 would instruct the Department of Homeland Security to perform a study that would identify impediments to effective Amateur Radio communication during disasters, using the ARRL as a resource. The study would be due to be completed within 180 days and its results reported to Congress for review and possible action.

What is needed at this time is to encourage as many US Representatives as possible to co-sponsor and to support HR 2160. This is where you come in.

We gathered a good number of letters at the ARRL Convention area of the Hamvention® this past weekend, but we need many more of these letters. The more letters, the greater the likelihood we will be successful.

There's a sample letter on the web that can be used as a guide for your own letter it is at <http://tiny.cc/ohqGD>. Personalize it with the name and address of your US Representative and your name, call sign and address, make any additional personalizing comments you feel appropriate and sign it.

Mail your letter -- not directly to the Representative -- to John Chwat, Chwat & Co., 625 Slaters Ln., Suite 103, Alexandria, VA 22314 (or FAX to 703-684-7594). Mr. Chwat heads the company that serves as the ARRL liaison with Congress. He will gather the letters he receives and deliver these personally to each Representative's office to add emphasis to the message contained in them.

Who is your Representative? If you are registered to use the Members Only page at [www.arrl.org](http://www.arrl.org), go to it. When Members Only opens, the name and address of your US Representative will be there, on the left side of the page. If you have not signed up to use Members Only, you can do this easily. You will need to have your membership number (from the QST mailing label). You can also find your Representative by going to <http://tiny.cc/Ugncl>. Enter your state and ZIP code to find your Representative. In many cases, you will need to know your ZIP+4.

At this time, please write only to your US Representative. Do not write to your US Senator or to your State Legislators. Please remember to mail or FAX your letter to John Chwat at Chwat & Co. Please also send an e-mail copy of your letter to Division Legislative Action Coordinator John Meyers, NB4K at [nb4k@arrl.org](mailto:nb4k@arrl.org).

## FCC Looks to Raise Vanity Call Sign Fees for Second Consecutive Year

(ARLB02)The FCC released a Notice of Proposed Rulemaking and Order (NPRM) on May 14 seeking to raise fees for Amateur Radio vanity call signs. Currently, a vanity call sign costs \$12.30 and is good for 10 years; the new fee, if the FCC plan goes through, will go up to \$13.40 for 10 years, an increase of \$1.10. The FCC is authorized by the Communications Act of 1934 (as amended) to collect vanity call sign fees to recover the costs associated with that program. The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign, but also upon renewing a vanity call sign for a new term. Instructions on how to comment on this NPRM are available on the FCC Web site.

The vanity call sign fee has fluctuated over the 12 years of the current program -- from a low of \$11.70 in 2007 to a high of \$70 (as first proposed in the FCC's 1994 Report and Order). In 2007, the Commission lowered the fee from \$20.80 to \$11.70. The FCC said it anticipates some 15,000 Amateur Radio vanity call sign "payment units" or applications during the next fiscal year, collecting \$201,000 in fees from the program.

The vanity call sign regulatory fee is payable not

only when applying for a new vanity call sign, but also upon renewing a vanity call sign for a new term. The first vanity call sign licenses issued under the current Amateur Radio vanity call sign program that began in 1996 came up for renewal three years ago.

Those holding vanity call signs issued prior to 1996 are exempt from having to pay the vanity call sign regulatory fee at renewal, however. That's because Congress did not authorize the FCC to collect regulatory fees until 1993. Such "heritage" vanity call sign holders do not appear as vanity licensees in the FCC Amateur Radio database.

Amateur Radio licensees may file for renewal only within 90 days of their license expiration date. All radio amateurs must have an FCC Registration Number (FRN) before filing any application with the

Commission. Applicants can obtain an FRN by going to the ULS and clicking on the "New Users Register" link. You must supply your Social Security Number to obtain an FRN.

The ARRL VEC will process license renewals for vanity call sign holders for a modest fee. The service is available to ARRL members and nonmembers, although League members pay less. Routine, non-vanity renewals continue to be free for ARRL members. Trustees of club stations with vanity call signs may renew either via the ULS or through a Club Station Call Sign Administrator, such as ARRL VEC.

League members should visit the "ARRL Member Instructions for License Renewals or Changes" page, while the "Instructions for License Renewals or Changes" page covers general renewal procedures for nonmembers. There is additional information on the ARRL VEC's "FCC License Renewals and ARRL License Expiration Notices" page.

License application and renewal information and links to the required forms are available on the ARRL Amateur Application Filing FAQ Web page. The FCC's forms page also offers the required forms.


My question to the members of this club is, "Just where do you expect the next generation of Hams to come from?"

## Scientists Predict Solar Cycle 24 to Peak in 2013

ARLS003 Scientists Predict Solar Cycle 24 to Peak in 2013

Scientists predict that Solar Cycle 24 will peak in May 2013 with 90 sunspots per day on average. At the annual Space Weather Workshop held in Boulder, Colorado last month, an international panel of experts led by NOAA's Space Weather Prediction Center (SWPC) predicted that Solar Cycle 24 will peak in May 2013 with 90 sunspots per day on average. If the prediction proves true, Solar Cycle 24 will be the weakest cycle since Solar Cycle 16 which peaked with 78 daily sunspots in 1928, and ninth weakest since the 1750s, when numbered cycles began.

The panel predicted that the lowest sunspot number between cycles -- the solar minimum -- occurred in December 2008, marking the end of Solar Cycle 23 and the start of Solar Cycle 24. If December's prediction holds up, at 12 years and seven months Solar Cycle 23 will be the longest since 1823 and the third longest since 1755. Solar cycles span 11 years on average, from minimum to minimum.

An unusually long, deep lull in sunspots led the panel to revise its 2007 prediction that the next cycle of solar storms would start in March 2008 and peak in late 2011 or mid-2012. The persistence of a quiet Sun also led the panel to a conclusion that Solar Cycle 24 will be what they called "moderately weak."

Although the peak is still four years away, a new active period of Earth-threatening solar storms will be the weakest since 1928. Despite the prediction, the scientists said that Earth is still vulnerable to a severe solar storm. Solar storms are eruptions of energy and matter that escape from the Sun and may head toward Earth, where even a weak storm can damage satellites and power grids, disrupting communications, the electric power supply and GPS. A single strong blast of "solar wind" can threaten national security, transportation, financial services and other essential functions.


The most common measure of a solar cycle's intensity is the number of sunspots -- Earth-sized blotches on the Sun marking areas of heightened magnetic activity. The more sun spots there are, the more likely it is that solar storms will occur, but a major storm can occur at any time.

"As with hurricanes, whether a cycle is active or weak refers to the number of storms, but everyone needs to remember it only takes one powerful storm to cause huge problems," said NOAA scientist Doug Biesecker, who chaired the panel. "The strongest solar storm on record occurred in 1859 during another below-average cycle." The 1859 storm shorted out telegraph wires, causing fires in North America and Europe and sent readings of Earth's magnetic field soaring, as well as produced northern lights so bright that people read newspapers by their light, he said.

Biesecker cited a recent report by the National Academy of Sciences that found if a storm that severe occurred today, it could cause \$1-2 trillion in damages the first year and require four to 10 years for recovery, compared to the \$80-125 billion of damage that resulted from Hurricane Katrina.

The Space Weather Prediction Center is part of the National Weather Service and is one of the nine National Centers for Environmental Prediction. It is the nation's official source of space weather alerts, watches and warnings. SWPC provides real-time monitoring and forecasting of solar and geophysical events that impact satellites, power grids, communications, navigation and many other technological systems.

## Military Vehicle Preservation Association To "Convoy" through the area



On Monday, June 15th, folks along the old Lincoln Highway will be treated to glimpse of history; a convoy of restored military vehicles will be coming through the area on its way from East Palestine, to Wooster.

This convoy is being sponsored by the "Military Vehicle Preservation Association" Whose website link was included in the February issue of Contact<sup>1</sup>. While researching this article, I was directed to their website (<http://www.mvpa.org/>)

The following excerpt from their website explains the purpose of the convoy better than I could.

"In 1919, the US Army's Military Transportation Corps (MTC) undertook

a transcontinental Convoy to demonstrate the need for a mechanized Army. This "hooves to wheels" plan to modernize America's fighting force needed an attention-getting event to energize Congress and the citizenry, and parading the Army's military might from coast-to-coast along the new Lincoln Highway was a great way to get demonstrate new vehicles

As part of its mission to honor our country's military vehicle history, the MVPA has decided to recreate the famous 1919 Convoy in 2009 as a 90th Anniversary celebration of the achievement and in conjunction with the nation's President Lincoln Bicentennial celebration. "
