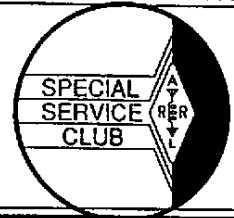

He also, along with his wife, Dianna, comprises the publication staff of the *Zero Beat*. Along with all this, he still finds time to help teach licensing classes.

But his expertise is not only for the benefit of the AARC. Just ask Patty &

Larry Hillier how much work KE8VE has done on various projects in the Beloit area, and you'll get an earful. 3-D human body released on internet

The information in this story came from the article written by Brenda C. Coleman, AP Medical Writer. The article in its entirety appeared in the November 28th issue of the Alliance Review.

"Sixteen months ago, a killer was executed in Texas. Today, his is a teaching tool for the world, made available on Internet as the first three-dimensional cadaver."

"The 'Visible Man' is a detailed atlas of the human body, assembled digitally from thousands of X-ray, mag-

netic and photo images of cross-sections of the body."

The article goes on to say that the digitized cadaver is free to anyone, but the data is so extensive that downloading it takes up to two weeks of uninterrupted time on the internet, and up to 50 Gigabytes of storage space. This is one hundred times the space available on the average home computer (or two thousand times the capacity of the *Zero Beat* computer system.

Info on Interference From "Hidden Fence"

Several members have reported interference from a new product called the "Hidden Fence."

This product uses a VLF transmitter, a large perimeter loop, a receiver on a dog collar and a shock device to help teach a dog to remain within your property lines.

Earlier versions of this were marketed without FCC approval and may generate interference to much of the HF band. The interference is characterized by a pulsing harmonic (like CW dits) every 35 kHz or so.

I contacted the Hidden Fence Company and was told that a "suppressor kit" is available free of charge. When you call, it is a good idea to ask for "Cheri" because others may not know about the suppressor kit. The ARRL RFI desk (that's me!) is looking for any report from someone who can verify that this suppressor kit is effective. Contact me here at HQ by phone, letter or email (ehare@arrl.org).

TIM: "Yo dude! What's new? You're 50 over 9 on my 13 element yagi. This is Tim, KM6ABC for ID. Hey, I can see the repeater antenna now. The new window in my shack is great. Hope you can hear me OK. This is KM6ABC for ID. Over Over".

AL: "Gee, Tim, I didn't realize you were using such a big antenna. I'll bet you could work it as well with one milli-Watt and a rubber duckie. You could also hear me well, since the repeater's transmitter, not mine, determines the signal strength at your end. Go ahead, Tim".

TIM: "Bummer ... eleven milli-seconds on my time response meter, Al. I'm practicing every opportunity I get, so I can respond within ten milli-seconds of the repeater's courtesy tone. Oh, almost forgot, this is KM6ABC for ID. Can't waste time, ya know. When you ragchew for a couple of hours, those seconds add up. Back to you, Al. This is KM6ABC, Tim in Folsom--on the hill. Over."

PRB-1 helps win another one. An amateur in Lyme, CT. has won a federal court go-ahead to install a 78-foot tower after a battle of some three years. F. Parker Heinemann, W1YG, was denied a special exception permit by the town planning and zoning commission. He then filed a civil suit against the town. In late October, US District Judge Gerard L. Goettel said that the town had acted in good faith based on the information it

New 144 MHz record

A new tropospheric ducting, continental distance record has been reported on the 144 MHz amateur band. On

November 5, Rene Shaw, WB4MJE, of Big Pine Key, Florida, and Serge Szpilfogel, VE1KG, of Halifax, Nova Scotia, worked over a 1687 mile path.

The previous record was 1468 miles, set by K5WXZ and K1RJH, and had stood since October, 1968.

WB4MJE is crucially located for this work at the southern tip of the Florida Keys.

This information comes from Al Ward, WB5LUA, who maintains VHF and UHF North American distance record information for QST's "World Above 50 MHz" column. Records on bands from 144 MHz to 678 THz are published in April QST each year.

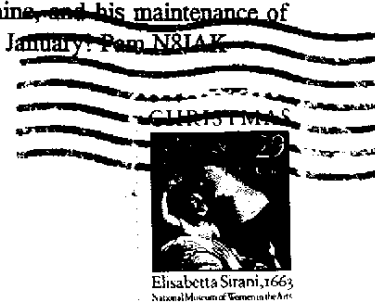
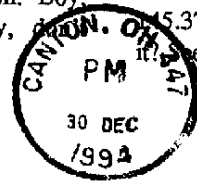
