

Zero Beat wins first place in Ohio Section Newsletter Contest!

The winners of the 9th annual Ohio Section Newsletter contest were announced at the Ohio Section Conference, on Saturday, September 16th. The Zero Beat named the first place winner, by our Ohio Public Information Coordinator, Scott Yonnaly, N8SY. While I didn't have presence of mind to jot down the scores. Scott tells me that there was only a three point difference between the top three finishers. I do remember that the Zero Beat finished with a total score of 84 points out of a possible 100. This isn't the first time, though, that the Zero Beat has done favorably in this contest.

In 1994, We missed out on an award for Honorable mention, by just a couple of points.

Then, in 1995, We won second place, scoring 82 points out of a possible 100. Coincidentally, the second and third place editors that year, were WX8G, and WX8F respectively.

ALLIANCE AMATEUR RADIO CLUB Bylaws

We, the membership, wishing to secure for ourselves the pleasures of an association of persons commonly interested in Amateur Radio, constitute ourselves, the: ALLIANCE AMATEUR RADIO CLUB and enact these by-laws for government. It shall be our purpose to further the exchange of information and fraternalism and individual operating efficiency, and to so conduct club programs and activities as to advance the general interest and welfare of Amateur Radio in the community.

ARTICLE I

Meetings of Membership

- A. The annual meeting of this club shall be held in the month of October for election of officers and trustees and immediately following the regular meeting in October.
- B. Regular meetings shall be held monthly as determined by the membership.
- C. The affairs of the AARC shall be managed by a Board of Directors: consisting of seven members elected in accordance with Article II and VIII of the Bylaws.
- D. Robert's Rules of Order shall govern all proceedings.

ARTICLE II

Officers

- A. The officers of this club shall number four (4). They are to consist of a President, Vice President, Secretary, and Treasurer.
- B. The officers shall be elected for a term of one year by ballot of members present at the annual meeting. New officers will take over their duties at the next regular meeting.
- C. Vacancies occurring between elections must be filled by special elections at the first regular meeting following the withdrawal or resignation.
- D. Officers may be removed from office by a three-fourths vote of full and sustaining membership.

ARTICLE III

Duties of Officers

- A. The President shall preside at all meetings of this club and conduct them according to Robert's Rules of Order. The President shall be responsible to ensure positions are filled and to conduct the business of the club. Examples of these positions are: Newsletter Editor, Equipment chairman, Program chairman, etc.
- B. The Vice President shall assume all duties of the president in his/her absence. He/she will also organize club activities and programs not otherwise designated to a committee, or other member.
- C. The Secretary shall record minutes of all meetings, keep a roll of members and receive applications for membership.
- D. The Treasurer shall receive and receipt all monies paid to the club, keep an accurate account of all monies received and expended, pay no bill without a majority vote at a regular meeting by the club, and shall make a brief financial report at each regular meeting.
- E. All officers shall, within ten (10) days after the expiration of their terms, turn over to their successors all records and property of the club, that is in their possession, that is pertinent to the office vacated.

October 2000

- A. All money received shall be under the supervision of the Board of Directors
- B. All money received shall be deposited within twenty (20) days of receipt, except not more than \$20.00 may be held in a petty cash fund for the purpose of making change, or for the payment of small bills.
- C. A majority ruling by the Board of Directors may approve expenditures of normal club business up to a limit of \$50.00 without the vote of the membership.

ARTICLE V

Dues and Membership

- A. A current valid Amateur Radio license issued by the FCC must be held to hold Full or Sustaining membership. Only Full and Sustaining members will have voting privileges and be eligible to hold office.
- B. Each member shall pay dues annually. All dues shall be due and payable upon acceptance into membership and must be paid in full before the annual meeting.
- C. Membership Dues and Classes:
 - a. **Sustaining Membership** -- Any licensed Radio Amateur, contributing \$15.00 or more annually to the club will be placed on the Sustaining Membership Honor Roll, for their generous contribution to the club treasury. The Sustaining member has full club privileges which include: voting rights, receiving a newsletter and holding an elective office.
 - b. **Full Membership** -- Any licensed Radio Amateur contributing \$10.00 annual dues, is entitled to all privileges as above except Honor Roll status.
 - c. Associate Membership -- Any person, with an interest in Amateur Radio, who does not hold a valid US. Amateur Radio license, but who pays \$5.00 annual dues, will be entitled to receive the newsletter, may attend meetings and other club functions, but cannot vote.
 - d. **Family Membership** -- Any family member, who holds a valid Amateur Radio license, who lives in the same household as the Full or Sustaining member, for the payment of \$1.00 dues, will have the same privileges, except that only one newsletter will be mailed to the household.
 - e. **Introductory Membership** -- Any person who receives his first Amateur Radio license as a result of completing an AARC-sponsored license course, is eligible for and shall receive a dues-free introductory membership provided that the following procedure is followed: when the course participant receives his license, he will inform the Board of his callsign, license class and effective date. Introductory members have the same privileges as Associate members. If an introductory member wishes to continue as a member of the AARC, he must apply for a new membership as specified in Article V prior to the next annual meeting. An introductory member who is eligible for full membership may upgrade to Full membership at any time by applying for a new membership as specified in Article V.
 - f. DUES -- Dues are to be pro-rated quarterly, as follows for new members (any one who has not been on the roster for at least one year):

Sustaining -	1. \$15.00	2. \$11.25	3. \$7.50	4. \$3.75
Full -	1. \$10.00	2. \$7.50	3. \$5.00	4. \$2.50
Associate -	1. \$ 5.00	2. \$3.75	3. \$ 2.50	4. \$1.25
Family	1. \$ 1.00	2. \$.75	3. \$.50	4. \$.25

The fiscal year begins on 1 April. Quarters are: (1) April - June; (2) July -September; (3) October - December; (4) January - March.

D. No member shall be free to make a commitment in the name of the club without a majority vote of the membership at a regular meeting.

ARTICLE VI

Intoxicants

A. No intoxicants shall be consumed at any regular or special meetings of the membership.

ARTICLE VII

Amendments

- B. These Bylaws may be amended by a majority vote of the membership.
- C. All proposals for amendments shall be signed by three Full and/or Sustaining members, presented in writing at a regular meeting, and not discussed or voted on until the next regular meeting.

ARTICLE VIII

Trustees

- A. There shall be three (3) elected trustees, to be decided on by a vote of the membership.
- B. Trustees terms will be for three years. One trustee is to be elected annually to replace the out-going trustee.
- C. The trustees shall have the control and management of the property of the club, subject only to the action of the membership, audit the books of the corporation, conduct the annual meeting, and further duties as may be required of them by the members.
- D. The election of the trustees shall be held at the annual meeting, except that if the office of trustee shall become vacant for any reason at any other time, nominations and election shall be held at the next regular meeting following the vacancy.
- E. Trustees may be removed from office by a three-fourths vote of full and sustaining membership.

ARTICLE IX

Assets

- A. Should this organization ever dissolve for any reason, the material assets of the club must be sold within ninety (90) days and the monies collected from sale is to be added to the common treasury. The Board of Directors shall satisfy all debts incurred by the organization with funds from the treasury. Remaining funds shall be equally divided among the paid-up full and sustaining membership at the time of dissolution.
- B. Such action upon the monies and assets of the club will be the responsibility of the Board of Directors at the time of dissolution.

Ohio Gov Bob Taft has declared a state of emergency for the southwestern Ohio community, which is about 15 miles east of downtown Dayton. The National Weather Service classified Wednesday's tornado as a F4 on the Fujita scale, with winds ranging between 207 and 260 MPH.

Greene County Emergency Coordinator Fred Stone, W8LLY, says a tactical net supporting the Greene County EOC was established on the Xenia Weather Amateur Radio Net 147.165 MHz repeater. A Red Cross net was set up to handle shelter support. Amateurs also were assisting with the damage assessment

effort. Hams also relayed information between Greene Memorial Hospital in downtown Xenia and outlying hospitals. The tactical net was secured Thursday afternoon.

Area residents said they had little or no warning that the storm was on its way. The weather service had issued a severe thunderstorm watch, but no tornado watches or warnings. The storm knocked out power to much of Xenia.

Repeaters remained operational, however. Amateurs reportedly helped to set up shelters and secure generators for emergency power to aid in searches for victims.

In addition to downed trees and power lines, heavy damage was reported at the Greene County Fairgrounds, where a festival was under way. The storm's winds overturned vehicles, shattered windows, and leveled or damaged dozens

of structures. Hail also was reported, and a church lost its roof. Most of a grocery store collapsed, and seven people were trapped inside.

"The big job now is cleanup!"

"Overall, everything operated very smoothly, said Stone, who also thanked amateurs from adjacent counties who checked in and offered assistance. "That's the way it should work, and does work, when the chips are down."

The Wednesday storm was a grim reminder of the deadly 1974 tornado that struck Xenia, killing nearly three dozen people and leveling much of the city. Forecasters say the September 20 twister followed roughly

Hollingsworth suggests steps to brighter Amateur future

Looking "beyond enforcement," FCC Special Counsel for Amateur Radio Enforcement Riley Hollingsworth, K4ZDH, has offered his ten personal suggestions to secure a sound future for Amateur Radio.

Speaking at the ARRL New England Division Convention August 26 in Boxboro, Massachusetts, Hollingsworth recapped the nearly two years since he took over Amateur Radio enforcement. Hollingsworth proclaimed the Amateur Service "fundamentally sound" today and said complaints now are decreasing.

With some major enforcement issues out of the way, Hollingsworth encouraged amateurs to "seize the moment" to ensure a bright future for Amateur Radio.

"Look beyond enforcement," he urged, "because if I do my job right, in five years you won't even remember my name." Hollingsworth said that while no one can predict the future, amateurs must invent heirs in an era of converging digital and RF technology.

And, he reiterated a phrase that has become a Hollingsworth mantra: "There is no reason why our Amateur Radio Service can't be the envy of the rest of the world." Getting there, he suggested, comes with each amateur's taking responsibility for his or her behavior on the air. Amateurs should encourage arrogant, negative operators to "take their anger and hate to the Internet," he said. "Every minute they are on the Internet is a minute they aren't on Amateur Radio."

Among other suggestions, Hollingsworth said hams should be proud of what they have accomplished. "Let the public know what you are, what Amateur Radio is, and why it's valuable," he said. He also urged hams to "operate as if the whole world is listening" and to never let ham radio "become the audio version of the The Jerry Springer Show."

He also called upon veteran hams to take newcomers under their wing and teach them "all you know" about the hobby.

Hollingsworth also expressed his support for the ARRL, which has backed his enforcement initiative on behalf of the FCC. "Take care of the one voice you have," he advised. "You must never doubt that a small group of dedicated people can change the world. They just did."

6. Teach the new licensees all you know. We've needed numbers for a long time.. *Respect* this wonderful legacy known as Amateur Radio that our mentors and Elmers gave us. Every time you key the mike or hit the key, think about what a legacy you were given and your duty to pass it on.

7. Enjoy ham radio. Celebrate it. But realize *it comes with responsibility*. Every gift of lasting value always does.

8. Stay away from arrogant, negative operators who know all the answers. They just haven't
